The mission of the St. Louis Learning Disabilities Association is to help all children learn, develop, and achieve. We work to provide the education and support necessary for children to be successful in the classroom and beyond. We believe that struggling students and their families are the most successful when surrounded by specialized services. We have a three-pronged approach to learning for providing testing, tutoring, and advocacy that will work with the family to design a network of support for assistance to the students.

In 2022, St. Louis LDA provided more than 44,000 interactions with 8,634 children, parents & teachers. This was made possible by our expert team at LDA, who I am proud to say, goes above and beyond to help our children utilize their strengths to overcome their challenges. We were proud to provide more than \$225,000 in free and reduced fees to our community.

Last year, our Early Childhood Outreach Program worked with early-childhood centers in the community to impact the learning of over 3,660 kids, 455 parents, and 650 educators while providing literacy-based learning opportunities. We worked with 50 families and 275 educators through our family advocacy and consulting program. We supported over 115 students with over 4,750 one-on-one tutoring sessions. We supported over 140 students by providing cognitive educational testing and reports with strategies to be implemented in the classroom based on their learning needs. Finally, we provided education and support in various schools across the community that requested LDA's help for the students, parents, and faculty in those individual schools.

I am proud of our LDA team for finding ways to deliver education and social-emotional services to those who come to LDA for help. And so, I thank all our donors-- like you-- for your part in continuing to give our struggling learners the gift of education, support, and understanding. With our partnership, we can bring hope to families as their children find success. We cannot do it without you! Thank you for helping us help kids. You are the best!
